1. Call to Order HEUMANN

Welcome and Introductions

The meeting was called to order at 10:04am

2. Public Comment

Lisa expressed disappointment with the BIDs involvement in a cleaning of Centennial Park. The BID should not be moving unhoused people or removing their belongings from public spaces.

Margaret was glad that Lisa brought up the concern about Centennial Park and agreed. She asked those present to please go see the Venice Library exhibit celebrating Black History.

3. Government Representative Liaison Reports

a. City of Los Angeles, Recreation & Parks

Sonya: The playground at Rose Av is under construction and about 1/3 complete. Muscle Beach will be re-opening with a ceremony on 3/14. In May there will be a Pretty in Pink Girls in Sports event. Currently there are many job openings at RAP and they are looking for maintenance staff, counselors, and sports/fitness instructors. RAP is working with the Council Office on paddle tennis improvements and getting new calisthenic equipment. RAP is working with LAPD and Park Rangers for clean ups. RAP will also be closing restrooms at Horizon, putting out porta-potties there in the interim, to make repairs.

Melody: In June Venice will have a Pride Festival. In late Summer there are plans for a car show and skate & paddle tennis events.

b. City of Los Angeles, Police Department

SLO **Contreras**: Stats for 2021 Pacific Division led in most stolen bicycles, catalytic converter thefts, and electric bike thefts. Jan-Oct '21 32% of stolen bicycles were in Venice. There is currently no enforcement code for bike chop shops. Please register your bike at bikeindex.org. There has been an increase in underground garage burglary. Safes have been taken from restaurants on Abbot Kinney. There is a decrease of 24% in violent crimes. Capt Embrich has made it a priority to have additional officers patrolling Ocean Front Walk during night hours. Additional Summer patrol officers will likely begin in April.

c. Los Angeles City Council, District 11

Isabella: A motion has been approved and waiting on a report from the city attorney regarding motorized scooters/electric bikes. Currently there is a clean up scheduled for Centennial Park on 3/7. The Windward bollards have been installed and are waiting for power from LADWP. Speedway will be striped to remind people that it is one way. The Council Office is also working on getting murals on OFW.

d. Los Angeles County Supervisor, District 3

Unable to attend today's meeting

e. CIRCLE, Urban Alchemy and Mayor's Office

Kirkpatrick: The pilot program, CIRCLE, has been going on for about 4 months. Focus has been on getting to know unhoused, business owners, and community members. A MOU with Home at Last was just completed and will start training on 3/2. Current operations do not support receiving external calls from a separate stakeholder phone number. All calls come in through 911, and people should continue to use the emergency line. SLO Contreras will send a flier that specifies which calls go to which agency.

Steve called Item 4a and 4b and introduced Marcus Lieber. Marcus went over the December '21 and January '22 Financial Statements. Steve confirmed that everyone reviewed 12/10/21, 1/7/22, and 2/4/22 minutes.

Jeff Goodman made a motion to approve all consent items. Connie Brooks seconded. The Board voted 6-0.

5. Venice Beach BID Staff Reports

a. Safe Team Report

Alan gave monthly report and informed that he will be moving to more foot patrol (rather than bike) to make sure that the team is more approachable.

b. Clean Team Report

Maria gave the monthly stats for December '21 and January '22 along with her report.

c. Executive Director's Report

POLAKOFF

Eleni introduced the Venice Beach Bulletin, which will be going out quarterly. Monthly stats will still be available on our website monthly, but will no longer be sent out monthly via email. Eleni announced that Nisa is no longer with the BID. We are hiring for an Operations Manager position.

Eleni identified current priorities: strategic planning to create a comprehensive 5 year plan and preparation for Summer. She shared presentation including before & after photos of graffiti removal & trash pickup throughout the district. She provided an update regarding LADWP Speedway Pipeline Project. Eleni responded to public comment, stating that she was aware of the situation and had spoken to staff. It was not a typical situation and the team did not "move" anyone. We will use the feedback given to learn and improve.

6. New Business

a. Consideration of Current Circumstances of the Existing State of Emergency and Local COVID Mitigation Rules: Determine whether it is safe to resume in-person Brown Act meetings of the BID or to continue remote meeting attendance for the next 30 days.

Steve called item 6a. He states that he believes we should continue with virtual meetings given circumstances. He asks for discussion.

Steve made a motion to continue remote meetings for the next 30 days, in consideration of their continuing to be concerns with Covid-19 and in-person meetings. Having considered the circumstances of the existing state of emergency regarding Covid mitigation and that state and local officials are still recommending social distancing, Steve moved that the Board find that these circumstances continue to directly adversely impact the ability of the BID to conduct meetings safely indoors in person and thus that all BID meetings subject to the Brown Act shall be conducted by remote access for the next 30 days. Jeremy seconded. Vote Yes 6-0.
